**U.S. slaughterhouse workers, truckers fuel
deadly piglet virus spread**

CHICAGO (Reuters) - Questionable hygiene practices among meat processing plant employees, freight truck drivers and others who work at hog slaughter houses are aiding in the spread of porcine epidemic diarrhea virus across the United States, according to research conducted by the University of Illinois staff.

PEDv is spread most commonly by pigs ingesting contaminated feces. The virus, which is deadly to very young piglets, does not pose a health risk to humans or other animals and the meat from PEDv-infected pigs is safe for people to eat, according to federal officials.

Swine veterinarian James Lowe and a group of veterinary peers said they gathered swabs and environmental samples last month from 669 livestock trailers at seven Midwestern slaughter facilities - before and after animals were unloaded and moved into holding pens.

The researchers found that 17 percent of the trucks that pulled into the facilities during this time had trailers that were contaminated with PEDv, according to an abstract summarizing the researchers' findings that was released earlier this month. At some plants, as many as 69 percent of the trailers arriving on site were contaminated with PEDv.

Of the trailers that arrived free of PEDv, about one in 10 trailers - 11 percent - became contaminated while at these facilities.

Scientists report progress in defeating swine disease PRRS [edited]

U.S. Department of Agriculture researchers are working to solve a swine disease that has a major negative effect on the pork industry. Nebraska is the nation's number-six pork producing state.

USDA scientist Dr. Joan Lunney says Porcine Reproductive and Respiratory Syndrome, or PRRS, costs U.S. pork producers money and pigs every year.

"Overall, in the United States, PRRS costs us \$642-million a year and if you take into account veterinary costs, it's one billion a year in the U.S. alone," Lunney says.

To alleviate this situation, Lunney and her colleagues in Beltsville, Maryland - just outside of Washington D.C. - have discovered a genetic marker that shows which pigs are resistant to the effects

of PRRS.

"We've been able to show that there is a region on swine chromosome four that is associated with decreased viral levels and increased growth," Lunney says. "So, this is really important because it means that we can help farmers now to decrease the effect of PRRS in their herds." With this knowledge, producers and animal breeders could introduce PRRS tolerant swine into their herds thereby reducing the effects of the virus.

"They would be buying pigs that are resistant, but not completely resistant to PRRS," Lunney says. "This is not a situation where we have zero PRRS. It is a 15% decrease in PRRS and an 11% increase in growth traits."

Senate Moves Towards Farm Bill Conference

The U.S. Senate took the necessary procedural steps to be able to move forward to get the Senate-passed farm bill to conference. By unanimous consent, the Senate sent its five-year farm bill back to the House of Representatives and requested a farm bill conference. Senator Debbie Stabenow (D-MI), chairwoman of the Senate Agriculture Committee is expected to name the 12 Senate conferees (seven Democrats and five Republicans) in the near future.

Senator Stabenow said, "We are, in fact, now officially sending back our Senate bill to the House and requesting a conference on the farm bill. This is a very important step. As everyone knows, we have been working very hard on a bipartisan basis in the Senate." The question is how soon will the House of Representatives name its conferees?
