## AAVLD PRESIDENT'S MESSAGE

Dear Colleagues:

I am pleased to report that the leadership of AAVLD has been fully engaged in a variety of issues of importance to our organization.

The December 23 announcement of the diagnosis of BSE in Washington State was a significant event and led to a flurry of activity within USDA and livestock industries across the country, with numerous meetings and phone conferences. The International BSE Review Team's recommendation that the US expand its BSE surveillance program and that testing be conducted in laboratories throughout the nation, with NVSL functioning as the reference lab, has provided opportunities for AAVLD labs to assume a pivotal role in helping to protect the country.

In the few months since our annual meeting, I, along with the Executive Committee, have continued to work with our partners in the USDA, USAHA, FDA, Homeland Security, and AVMA to address animal health issues. On behalf of the organization, we have traveled to meetings, participated in numerous conference calls, and assisted in developing policy documents and other recommendations for animal surveillance systems for diseases such as AI, END, CSF, and BSE. In addition, I have worked to make sure that all of our leadership positions are filled. Committee chairs and members were selected shortly after the annual meeting; the updated list will be published in the forthcoming 2004 membership directory. I would like to thank all who volunteered to serve AAVLD in the coming year.

An important accomplishment in December was selection of Dr. Jerry Saliki as the new editor of the *Journal of Veterinary Diagnostic Investigation*. Dr. Saliki is with the Oklahoma State Veterinary Diagnostic Laboratory and is exceptionally well qualified to assume this important leadership position. He is working to maintain the stature and reputation that the journal has attained under previous editorial leadership. He is currently working on enhancements such as online manuscript submission and review, which is expected to reduce publication time.

In the past few months, I attended the AVMA's House of Delegates (HOD) Assembly and Leadership Conference, participated along with the Executive Committee and USAHA's Government Relations Committee in a meeting in Washington, DC, and convened the Winter AAVLD Executive Board Meeting in Las Vegas. I would like to provide you with highlights of these meetings, as well as other pertinent information resulting from memorandum of understanding calls with NVSL and other items of interest.

**AVMA House of Delegates Assembly and Leadership Conference:** Key discussion items at this meeting included review of proposed revisions to the AVMA Constitution, animal welfare issues, current initiatives by the Government Relations Division, and updates on BSE. While AAVLD does not have a seat in the HOD, we are given membership on the Advisory Panel, which does allow us to participate and have a voice in animal health and regulatory issues concerning the profession. Our goal should be to gain full membership in the HOD, which requires that 90% of our membership also be AVMA members. Currently only about half of our members hold AVMA membership, so we have a way to go. While attending the conference, I was successful in securing approval of the AVMA Executive Board to direct the Government Relations Division to lobby Congress for funds to expand the National Animal Health Laboratory Network (NAHLN). Securing funding for the NAHLN is one of AVMA's top legislative agenda items.

**National Animal Health Laboratory Network:** I have continued to represent AAVLD on the NAHLN Steering Committee. The committee has just completed and submitted policy and membership criteria documents to the 12 original pilot laboratories for review and signature. The committee also recently decided to offer membership (without funding support from USDA/CSREES) to those labs that may wish to join the NAHLN. Membership invitations will be sent to laboratories once the 12 pilot labs have their staff trained and proficiency tested for the original 8 exotic agents. AAVLD's position is to expand the NAHLN to include all states and increase the scope of testing from the 8 exotic diseases to other select agents/high consequence pathogens, toxins, and zoonotic diseases. We were pleased to see that President Bush's FY 2005 budget has \$30 million earmarked for both plant and animal laboratory networks. CSREES estimates that about half would be allotted to the NAHLN. If the funding line is maintained in the final FY 2005 budget, funding for more labs are likely to be added to the network. We are continuing to work with our partners at USAHA and AVMA to secure a full funding level of \$107 million for the NAHLN.

**Laboratory Response Network (LRN/CDC):** In early December, we were requested by CDC to develop policy documents that addressed evaluation of veterinary diagnostic labs for entry into the LRN and establish goals, set benchmarks, and define activities for participating laboratories. The status of this initiative is pending, and we remain hopeful that funding will be forthcoming. CDC has urged state public health agencies to consider use of the states' unallocated 2003 funds to support the involvement of their state veterinary diagnostic laboratory in the LRN. Since 2003, approximately 8 veterinary diagnostic laboratories have been added to the LRN at the request of their state Department of Public Health.

**Annual conference:** Planning for the 2004 annual conference is well under way. The AAVLD portion of the meeting will take place October 21-25 in Greensboro, North Carolina. The convention hotel has been site visited by Dr. Blanchard and Donna Dare and meeting room assignments have been made. The Greensboro venue appears to be an excellent conference site. Dr. Gary Osweiler issued a call for papers in the November 2003 newsletter, and everyone is encouraged to submit an abstract. This year, the AAVLD and USAHA will again co-sponsor a joint plenary session, the theme of which will be decided very soon.

These are just a few highlights from what has been a very busy past five months. As always, I welcome your comments, suggestions, and concerns, so please feel free to contact me at any time.

You may have noticed, if you are a regular user of the AAVLD website, that it has changed. As newly appointed Web Editor, I found that this redesign was already underway, primarily to allow it to function better as a database which will facilitate the continual update and addition of more information. The website is a work in progress and the initial changes were an attempt at better organization. A site map is being prepared so that it will be easier to find specific items. The site is fairly barebones and spare in appearance, but our primary concern at this point is functionality. I have tried to create two particular areas that I thought would be beneficial: 1) Official AAVLD business, and 2) Member services.

The business areas will hopefully be useful to communicate current issues under discussion or of interest to the organization as a whole. A page or site has been created for each committee through which the chairpersons can communicate with committee members and archive past activities.

The member services area includes directories of laboratories and members, the newsletters, JVDI archives, and proceedings of past meetings. An area under member services has been set up called Diagnostic Resources. I envision this as a reference area that may be useful to diagnosticians in their day-to-day work. So far we have included the IHC database, a document on serologic interpretation and a few SOPs.

The Listserv has proven to be a tremendous source of information, but personally I have not been diligent enough in saving some of that information for later use. At the very least, I would like to see if we can save to a directory in the Diagnostic Resources section references to unusual or little used tests and where they can be run. Perhaps a catalog of SOPs as they are developed by the various committees could be deposited here.

Another planned improvement is better organization of the position announcements. For a period of time, our Webmeister Randy Berghefer wants the entrance page for members to be the personal data page. We would like you to review this data and make sure it is correct. These are just initial thoughts and additional changes will likely occur. I will be glad to consider any suggestions as they occur to you. I once heard it said that some people are always looking for mistakes and so I have included some of those as well so perfectionists will not be disappointed. 1. The meeting was called to order by Willie Reed at 1:10 PM.

2. **APPROVAL OF MINUTES:** Minutes of the October 10, 2003 Executive Board Meeting were reviewed. A motion was made to approve the minutes (Maxie), seconded (Torres), and carried unanimously.

3. **TREASURER’S REPORT:** Alex Ardans presented the report of the Treasurer as follows:

Dr. Ardans reported that AAVLD had 264 members registered at the annual meeting, along with 133 members of both AAVLD and USAHA, 475 USAHA members, 210 non-members, and 41 complimentary registrations for a total registration of 1123. Major meeting expenses included audio/visual \$9,000, President’s reception \$8,000, and exhibitor food \$12,500. Net meeting earnings were approximately \$60,000.

The Secretary/Treasurer’s office has recently learned of an unexpected expense from the University of Missouri concerning the JVDI editor support position for which clarification will be sought.

Current AAVLD membership is 1109. In response to a question regarding the number of members that have not renewed for 2004 (269), it was pointed out that this number is similar to that in previous years, and that the Secretary/Treasurer’s office continues to receive late renewals throughout the year.

The online registration presented by Dr. Ardans and approved by the Board in July has been taken over by USAHA and will be done in house by USAHA IT staff.

A motion to accept the treasurer’s report was made (McElwain), seconded (O’Toole), and carried unanimously.

#### **4. PRESIDENTS REPORT**

Willie Reed announced that he has selected all of the committee chairs and co-chairs. A successful December JVDI editor search resulted in the selection of Dr. Jerry Saliki. Dr. Reed expressed his thanks to the committee for their help in reviewing applicants.

Dr. Reed reported on the AVMA House of Delegates meeting where he also met with Mike Chaddock to request AVMA support for the NAHLN. A request for NAHLN support will be taken to the AVMA Executive Committee meeting this spring.

The NVSL MOU calls are continuing with discussion of proficiency testing, training and NAHLN issues.

The AAVLD Executive Committee met with the USAHA Government Relations Committee in Washington DC the week of February 9<sup>th</sup>, 2004. The group met with USDA Secretary Ann Veneman and had several discussions including specific AAVLD issues including the NAHLN. The committee also met with representatives from CSREES, ARS, Homeland Security and APHIS administrators.

Terry McElwain noted that in the MOU it states that a task force is to be assigned every year in addition to working groups to lay out objectives. AAVLD may want to take a look at and reinstate the task force. The next call will be in March, and this may be added as an action item/agenda item.

#### **5. COMMITTEE REPORTS**

##### **A. Accreditation**

Leon Thacker reported that the Accreditation Committee met February 17 from 8 AM – 12 PM at the Gold Coast Hotel in Salon H. All members of the Committee were present. The Committee heard site visit reports from Wisconsin and British Columbia. The Committee has 15 labs to visit in 13 states for 2004. Virginia is a new lab to be visited this year, and the system has five labs to visit. Dr. Thacker reiterated the timelines for incorporation of the new Essential Requirements. April 1, 2004 is the deadline for each accredited lab to appoint a QA manager and submit a Quality Manual, which describes their quality system and an implementation plan for their quality system with timeline and appropriate milestones to meet revised AAVLD essential requirements that incorporate appropriate OIE Standards. Beginning January 1, 2005 the accreditation site visits will include an audit for compliance with the laboratory's implementation plan milestones. It was suggested in the Accreditation Committee's meeting that a refresher course be held for the AAVLD assessors. A conference call was held during the lunch hour with Ken Stoub, Terry McElwain, Leon Thacker, and Alex Ardans regarding arranging the refresher course. Ken Stoub will also develop a checklist tool for AAVLD Accreditation visits and train the assessors on its use. The Accreditation Committee informed the Executive Board that the eight-hour refresher-training course will be held on July 23, 2004 with Ken Stoub. Dr. Thacker also announced that quality managers might be asked to serve on site visits in the future.

##### **B. Publications**

###### **i. JVDI**

Dr. Reed welcomed Dr. Jerry Saliki as the new JVDI editor.

Dr. Saliki reported that he has hired a very competent editorial assistant, Heather Heaton, who has a degree in technical writing. The new editorial office is now fully functional and the next issue of JVDI will include the new editorial board with staggered terms.

Dr. Saliki reported that in 2003 there were 156 manuscripts submitted. As of last week 64 manuscripts were accepted and 51 were rejected. There are 48 manuscripts that have been accepted, but not yet published. He has slated 21 of those manuscripts for the July issue and 27 for the September and November issues. Manuscripts currently being accepted will not be published until November 2004 or January 2005. Dr. Saliki is planning to increase the size of the next few issues of the journal in order to decrease the manuscript

backlog and bring it under control. He would like to have only 1.5 times the amount of manuscripts for one journal in backlog. The current time from manuscript receipt to publication is 12-16 months. Dr. Saliki would like to attempt to cut down this turnaround time to 12 months from receipt to publication and is developing a database to help track turnaround times. He presented a proposal to the board for use of a web-based manuscript submission and review system for JVDI and would like to move ahead in the next 12 months. Hard copy submissions would still be accepted in addition to the new electronic submission method. Dr. Saliki will obtain at least one additional estimate on another company's system. After discussion a motion to authorize forward movement with Dr. Saliki's proposal was made (Ardans), seconded (Maxie) and carried unanimously. In the long-term Dr. Saliki would like to move towards online access to the journal for patrons and subscribers. Donal O'Toole suggested putting the date of acceptance at the end of each article.

Alex Ardans requested suggestions for additional support for the JVDI in order to reduce its cost.

**C. Program Committee**

Gary Osweiler reported that most of the program committee from 2003 will serve again this year. The call for papers has been sent out and he will continue to send reminders. The call is also posted on the web site.

CL Davis is planning a workshop on Neuropathology and other possible pre-meeting symposia include Select Agent Identification, which would be held at the North Carolina Department of Health, and a Food Safety symposium.

Possible topics for the joint plenary session include surveillance systems and approaches, progression of animal identification systems, BSE, its ramifications and natural history of the incident in the US including diagnostics along with the CDC/public health view of the disease, avian diseases including avian influenza and public health implications, and Tuberculosis and Brucellosis test validation consistent with OIE standards. It was suggested that the joint session concentrate on surveillance and touch on different diseases and public health concerns.

Dr. Osweiler solicited suggestions for the AAVLD plenary sessions. Suggested topics included focusing on the diagnostic side of some of the suggested joint plenary session topics, BSE diagnostics including Washington State University's role during the episode, and Brucellosis transmission in elk with suggested speaker Don Montgomery.

**D. Canada Report:** Bill Yates provided the following update:

**New Minister of Agriculture.** "Mr. Robert (Bob) Speller was named Canadian Minister of Agriculture and Agri-Food in December of 2003. Mr. Speller has been a member of Parliament from Ontario since 1988, and has considerable experience on Parliamentary Standing Committees including Agriculture, Foreign Affairs and International Trade, and Health.

**Canadian Animal Health Laboratorians Network Meeting.** Our animal health laboratory scientists will convene for the third annual meeting in this new format, 16-19 May 2004 in Guelph, Ontario. The meeting is aimed at interested laboratorians from academia, government, and the private sector, featuring keynote speakers and cases over several days. Guests such as AAVLD members are most welcome. The first two meetings were held in our nation's capital, Ottawa, Ontario, and we plan to rotate between that location and the four Canadian veterinary colleges, starting with the Ontario Veterinary College at Guelph this year where Dr. Grant Maxie is

head of the organizing committee. Dr. Terry McElwain spoke at the meeting last year, during his term as President of AAVLD. The theme this year is “Emergency Preparedness”, and keynote speakers include Dr. Terry Wilson, USDA, on “Asymmetrical threats to agriculture – agroterrorism, biological crimes, and biowarfare targeting animal agriculture”; Dr. Harvey Artsob, Health Canada, on “Emerging/non-emerging arboviral diseases and the veterinary/public health interface”; Dr. Dorothee Bienzle, University of Guelph, on “New tools for the pathologist at the emerging disease front”; Dr. John Prescott, University of Guelph on “Murder, mayhem, and chaos: Changing bacteria in a changing world”; and Dr. Sharon Hietala, University of California, Davis, on “Exotic Newcastle Disease – laboratory response to a California animal health emergency.”

**BSE Update.** Canada has its enhanced surveillance system up and running as of January 2004, with a plan to do proportionate sampling by province of 8,000 animals in calendar 2004, ramping up to 30,000 per year over the coming 5 years. This is in keeping with OIE guidelines. Samples will be tested by Western blot rapid test kits in the various federal and provincial laboratories of the Canadian TSE Lab Network, with confirmation of any reactors to be done by immunohistochemistry at our BSE Reference Laboratory in Winnipeg. Cohorts of the Holstein cow diagnosed in Washington State during December of 2003, which originated from Canada, are being traced out. All those depopulated and tested to date have been negative. We hope we are done with these cases now, but of course the international BSE panel reports in both Canada and the US said that we could see a small number of further cases in either country and still be within expectations for our risk categories in North America.”

#### **E. Membership**

Donal O’Toole reported that the current membership is 1109. The total membership at the end of 2003 was 1249. At the annual meeting last year the possibility of holding a new member orientation at the annual meeting this year was discussed. One item that would be discussed is the organization’s committee structure, which may be difficult for new members to understand.

#### **F. Credentials**

No report.

#### **G. Foundation**

Barb Powers reported that last year the Foundation Committee developed a letter to solicit donations, which will be sent electronically via the AAVLD email list.

The level of recognition for corporate sponsorships was discussed. It was suggested that sponsors be announced during and posted at the president’s reception, general session, etc. Bio-Rad has agreed to donate to the Foundation, however their donation depends on their involvement with the annual meeting. Dr. Powers asked the committee for approval on whether she should go ahead with donation solicitation approaches as long as they do not conflict with annual meeting program activities (Bio-Rad, Cepheid, Ventana). It was suggested that she ask the corporate contact for the meeting who she should contact for a larger gift for the foundation.

#### **H. NVSL Report:** Randall Levings, Director of NVSL provided the following update:

The budget for 2004 maintains increases received in 2003 to the 2002 baseline budget. Veterinary diagnostics received a slight increase, avian influenza funding was reduced along with Johnne’s disease, however chronic wasting disease funding was increased and eight million was received for the NAHLN. The 2005 budget has gone to Congress, however the explanatory notes are not yet published. The budget for 2005 would provide and increase of 50 M for BSE, 6 M for Tuberculosis, 30 M for CSREES, and 2.4 M for Plum Island.

Master plan: The construction launch with Secretary Ann Veneman was held in January. In the 2005 budget there is 178 M for the master plan with the rest of the money for the BSL-3 facility scheduled for the 2006 budget. A change in plans for contractors has been approved.

The 2004 budget also included a two million dollar line for biodefense, which NVSL hopes to divert to keeping Plum Island in the agriculture mission.

The Department of Health Services held a press day February 16, 2004 regarding a book that was published on Plum Island entitled Lab 257, which suggests that the source of Lyme disease, West Nile Virus and other various diseases was escape/release from Plum Island.

Select agent inspection was held at the end of October. CDC security and biosafety meeting was held on January 27<sup>th</sup>. They wanted to know the impact of the select agent rule on veterinary laboratories. Six bullets were obtained from AAVLD discussion lists on the topic.

Avian Influenza: Two flocks in Delaware were found with H7N2, which is the old AI sequence from live bird markets. In Pennsylvania flocks were found to have the H2N2 strain that were picked up on routine surveillance testing. One flock was quarantined. No flocks were affected in New Jersey live bird markets where testing has been done on four live bird markets. Testing for the New Jersey flocks is being done at NVSL, the Delaware testing was done in Delaware and confirmed at NVSL, and the Pennsylvania testing was done in Pennsylvania using Directagen tests. As of yet no flocks have been destroyed.

## **J. Miscellaneous Reports**

### **i. Government Relations**

Willie Reed reported that on a recent trip to Washington DC the Executive Committee toured the impressive emergency operations command center at the Riverdale facility. Time was spent discussing national programs including the National Animal ID plan, which has been out for some time and will probably now be realized.

The Committee met with USDA Secretary Ann Veneman and had a good discussion with her concerning AAVLD. Dr. Reed noted that the long-term future for Plum Island is a concern. Of the scientists and staff, half will soon report to a new boss. No major investments in infrastructure are scheduled for Plum Island and there are suggestions that the focus will be on a new lab at Fort Detrick.

Dr. Reed also reported that AVMA has plans to either construct or purchase a building in the Washington DC area. If this happens USAHA may be offered the opportunity to rent space in the new AVMA building. In this event it is likely that USAHA may again request that AAVLD join in hiring an executive director to represent both organizations, and to share in the costs of the rent. The executive director would be based in Washington DC and work out of the new AVMA building. This opportunity would provide AAVLD with a presence in Washington.

Alfonso Torres suggested that he would like to see standards for biocontainment undergo a National Academy of Sciences review. It was agreed that AAVLD would be supportive of the review.

## 6. OLD BUSINESS

### A. Network Updates

Standards Training for the NAHLN occurred January 13<sup>th</sup>-16<sup>th</sup> in Las Vegas, NV on HL7, SNOWMED, LOINC and RELMA. Exotic Newcastle disease and Johne's disease are being used for the pilot. A manual reporting tool is currently being developed. The NAHLN is working with FERN, which uses eLEXNET and is developing a methods repository modeled on eCAM. NAHLN is ahead of FERN in regards to nomenclature, however FERN is ahead on matrices. USDA and FDA jointly fund the FERN.

A new budget is being worked up to include the cost of testing for Classical Swine Fever surveillance and a timeline for the validation of RT PCR has been distributed.

The NAHLN Steering committee made a decision at their most recent meeting to open up the NAHLN for membership to any accredited laboratory if the laboratory felt that they had the money in their budget to sustain NAHLN membership. These laboratories would be next in line when funding becomes available. Approximately half of the \$30M in the 2005 budget will be available for the animal side and will be used to expand the network. There are currently 7-12 applicants for the NAHLN coordinator position. Some NAHLN funding progress has been made with funding appropriated for 2004, however considerable effort needs to be made with Congress for expansion funding.

AVMC is soliciting bioterrorism money and their proposal looks a lot like the NAHLN White Paper, which may create a potential for confusion and diversion of monies.

### B. END Surveillance

Randall Levings reported that there has been no change in funding for END surveillance. Approximately \$900,000 is available for END PCR set up. A call will be sent out to all labs for equipment needs. All laboratories involved have people trained for testing, but not all have done proficiency testing. DPAs have gone out to all 29 laboratories, however start up has been delayed due to BSE. It was discussed that there needs to be a way for high risk states to communicate what will happen and how to submit in case that they need to submit for testing. A template will be sent out to each state to list individual contacts and submission information, which can be sent to veterinarians.

### C. EPA Region 8 Waste Disposal Regulation Update

Donal O'Toole reported that the draft of the Best Management Practices document for waste disposal has been sent out as approved by the Executive Board. He noted that according to the EPA regulations Environ LpH can be used at half strength that was in the document, and laboratories have to get a state FIFRA (Federal Insecticide Fungicide and Rodenticide Act) exemption to use Environ LpH. Dr. O'Toole has also developed a Best Management Practices document for BSE. The EPA is planning to reclassify prions as pests.

### D. Liaison Updates

i. NIAA: The NIAA Annual Meeting will have a session on BSE.

## 7. NEW BUSINESS

### A. BSE Surveillance Plan and BSE International Review Committee

Randall Levings reported that the number of cattle to be tested for BSE and where testing will be done has not yet been determined. Of 600,000 at risk cattle, options include testing 40,000, 61,000, 245,000 or testing as many of the 600,000 as possible. Other possibilities include the "live, healthy old cow surveillance plan" or a combination of both types. Testing will most likely be performed in multiple laboratories. These laboratories may use one testing tool or multiple tools. It is up to Secretary Ann Veneman to determine what will be done.

There was discussion regarding State laboratories performing the BSE testing. AAVLD would like to see the testing remain in the hands of public laboratories.

**B. USAHA/AAVLD BSE Surveillance Committee**

Don Lein solicited AAVLD participation with USAHA on the USAHA BSE Surveillance Committee. The Subcommittee will consist of Willie Reed, Terry McElwain, and Alex Ardans. They will draft a statement to USAHA.

**C. LRN/CDC Funding**

Willie Reed announced that the National Center for Infectious Diseases is investigating directed funding for veterinary laboratories to participate on the LRN. Documents to evaluate veterinary laboratories for inclusion in the Laboratory Response Network were created and sent for approval. The National Center for Infectious Diseases has a list of all state laboratories and contact information. If funding is approved procedures are in place to roll it out quickly. Approval for veterinary laboratory participation still must go through the state Public Health Laboratory.

**D. Strategic Planning Committee**

Willie Reed reported that the Long Range Planning Committee was dissolved last year. He would like to replace this committee with a Strategic Planning Committee to continue to look ahead. Dr. Reed will work developing the committee and will make appointments.

**E. Clinical Pathology Committee**

Willie Reed reported that he was contacted by Claire Andreason to see if AAVLD was interested in establishing a Clinical Pathology Committee. It was decided to make a Clinical Pathology Sub Committee to the Pathology Committee. Dr. Reed will work with Donal O'Toole to set up this Sub-Committee.

**F. LRN IT Steering Committee**

The Laboratory Response Network formed an IT Steering Committee to coordinate development of IT systems. They have given VDL a seat at the table. Jim Case will represent VDL on this committee. The informatics are not very developed for LRN as of yet. Dave Kinker will serve on this committee as a NAHLN representative.

**G. Joint Society of Toxicologic Pathology (STP)/American Society for Veterinary Clinical Pathology Regulatory Affairs Committee (ASVCP)**

Terry McElwain will serve as the AAVLD liaison on the joint STP/ASVCP Regulatory Affairs Committee. The main goal for AAVLD will be to speak to anything that may conflict with federal initiatives.

**H. Letter from Don Lein (USAHA) on Animal ID**

Willie Reed distributed a letter drafted by Don Lein on behalf of USAHA to the board for approval of cosignature on behalf of AAVLD. After discussion a motion to have Dr. Reed serve as a cosigner on behalf of AAVLD with the addition to the letter of a statement that the Animal ID system must be ISO certified was made (Wilson), seconded (Ardans), and carried unanimously.

**8. NEXT MEETING**

The next meeting of the Executive Board will be held Saturday, July 24<sup>th</sup>, 2004 in Philadelphia, PA in coordination with the AVMA annual meeting.

## COMMITTEE UPDATES

### Quality Assurance Committee

The Quality Assurance Committee provided significant input to the new Essential Requirements For An Accredited Veterinary Diagnostic Laboratory, Version 2.0, October 22, 2003 now posted at [www.aavld.org](http://www.aavld.org) on the AAVLD members only site.

QA committee members continue to communicate with each other about how their laboratory is incorporating the new quality assurance standards and provide a resource to each other via the email discussion list. The members are currently heavily involved in meeting the AAVLD April 1, 2004 requirements of naming a quality manager, writing a quality manual, and writing an implementation plan for building a quality system. This information will be submitted by laboratory directors to the Accreditation Committee for review, and will provide the basis for QA aspects of upcoming site visits.

As laboratories name quality managers, they are added to the QA Committee roster, which stands at 41 committee members as of March.

Committee members also indicated their willingness to participate in training and in the QA aspects of future site visits, should AAVLD conclude that such participation is warranted.

### AAVLD Veterinary Analytical Toxicology and Mycotoxins and USAHA Environmental Residue Committee

February 2004 update from committee chair Brent Hoff:

No formal activities has taken place since the October meeting , but much case discussion as well as some discussion on Method Validation Documentation to Meet OIE/ISO/AAVLD Standards, has taken place via VETTOX list serve and by phone.

The 2003 meeting included three areas of interest and for follow up in 2004.

- 1) Dr. Gary Osweiler updated the group on the FDA-CVM Chemistry Analytical Information Database developed by Iowa State University. This project will be updated and continued this year.
- 2) Dr. Bob Poppenga gave a presentation on Chemical Agroterrorism. Some of the most economically significant impacts on North American agriculture in the past have resulted from residues (e.g., dioxins, dieldrin, chlorinated hydrocarbons, PBB's etc.). The possible residue impact will also be discussed this year.
- 3) Last years' meeting included a section on Method Validation and Documentation to meet AAVLD (OIE/ISO) Standards. This will be the focus of the 2004 meeting.
